Use of Internet and e-mail in school

As part of their work in Information and Communication Technology (ICT) and across other subjects, we offer the children supervised access to the Internet and school (secure) e-mail - for example, to communicate with children from other schools.

The Internet is a rich source of information and educational activities which are of great benefit to the children. However, we understand there are concerns about inappropriate materials - **the school takes a range of measures to minimise these risks:**

- All access to the Internet is **supervised by adults**
- A **high level filtering system** is in operation. This allows access only to children's search engines and prevents access in response to inappropriate wording.
- Children are **not allowed access to chat rooms** at any time
- Children are taught about **safe Internet** (e' safety) use by their teachers

Before we allow children to use the Internet at school, we must obtain parental permission. Before a child is allowed access, the pupil and parents/ carers of, **must** sign and return the 'Internet use permission slip' below - as evidence of their acceptance of the school's rules for responsible use of these facilities.
