# Don't let your child miss out!

Did you know that extra money could be available to help your child's learning and development?





### How do I register?

If you have more than one child at school, please do not assume they are automatically added. You will need to register each child individually.

Currently, all pupils in Reception, Year 1 and Year 2 at Thorpe Acre Infant School are entitled to a Free School Meal thanks to a different government funding scheme known as universal infant free school meals (UIFSM). You shouldn't confuse UIFSM with Free Schools Meals and the Pupil Premium.

## Does my child have to eat the Free School Meals?

No. Pupils who are registered for Free School Meals don't have to eat them. If you're eligible but you want your child to have packed lunches you should still register because the school will receive the funding which can support your child in other ways.

# Your child might be eligible for Free School Meals, therefore Pupil Premium, if you access:

- Income Support
- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

## What is Pupil Premium?

If your child is eligible for 'Free School Meals' and you register them for this, we'll receive extra funding called 'Pupil Premium'. We use this extra money to improve the educational provision and resources at the school. By applying and being accepted, your child will still be able to bring in a packed lunch if they wish to do so. You could then be eligible for the government's Free School Meal vouchers during the school term holidays, should they continue to provide this.

## What is Pupil Premium funding?

Pupil Premium funding from the government is given to schools to help pupils reach their full potential, regardless of their background or financial situation. It's provided for pupils who:

- Are registered for Free School Meals;
- Have been registered for Free School Meals at any point in the past 6 years;
- Are, or have been, in care of a Local Authority;
- Have parents in the regular armed forces.

At Thorpe Acre Infant School, we receive extra funding for every pupil who is registered for Free School Meals. This extra money could make a real difference to the quality of education we offer.
